

Tokyo Bay eSG Partner Recruitment Guidelines

1. Purpose of Recruitment

In conjunction with the establishment of the Tokyo Bay eSG Partner, we are seeking to recruit Tokyo Bay eSG Partner members (hereinafter referred to as "Members").

2. Eligibility and Qualifications

(1) Applicants

Companies, NPOs, universities, research institutes, financial institutions, investors, government agencies, and other similar organizations with legal personality (Individuals are not eligible to apply.)

(2) Eligibility

All applicants must meet the following criteria.

- a. The initiatives must be consistent with the philosophy, future vision, and urban vision set forth by the Tokyo Bay eSG Project.
- b. Demonstrate alignment with the objectives and activities of the Tokyo Bay eSG Partners.
- c. Conduct business activities in a fair and ethical manner, in compliance with all applicable laws and regulations.
- d. Not disqualified for any of the following reasons:
 - (a) Any party with outstanding obligations to the Tokyo Metropolitan Tax Bureau, the National Tax Administration, the Japan Tax Agency, or any other relevant tax authority.
 - (b) Any entity that has filed or received an application for corporate reorganization, civil rehabilitation, or any other similar application.
 - (c) Those in violation of labor-related laws and regulations.
 - (d) Individuals who have been subject to a business suspension order or administrative penalty.
 - (e) Those who have been denied various types of subsidies.
 - (f) Any individual or entity found to be in violation of the Tokyo Metropolitan Government's Gang Exclusion Ordinance.
 - i. The juridical person, etc. is a crime syndicate or an officer, etc. of the juridical person, etc. is a member of a crime syndicate.
 - ii. An officer, etc. is using crime syndicate or crime syndicate member for the purpose of pursuing unjust profits for himself/herself, his/her company, or a third party, or for the purpose of inflicting damage on a third party, or the like.

- iii. The Officers, etc. directly or actively cooperate with or are involved in the maintenance or operation of crime syndicate or crime syndicate member by supplying funds, etc. or providing benefits to crime syndicate or crime syndicate member.
- iv. The Officers, etc. have a socially reprehensible relationship with crime syndicate or crime syndicate member with knowledge that they are crime syndicate or crime syndicate member.

3 Application Procedure

(1) How to apply

Applicants should apply through the designated registration form on the Tokyo Bay eSG Project website (<https://www.tokyobayesg.metro.tokyo.lg.jp/>).

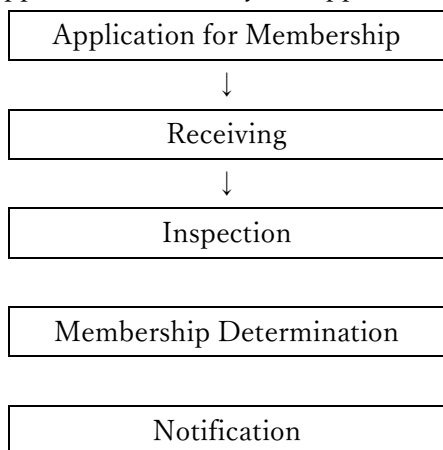
Please apply through the designated registration form. Applicants may be asked to submit documents to prove their qualifications as necessary to confirm eligibility.
